Andy reminded us cameras are no good for cleansing prosecution. Marion noted workers are watching hundreds of screens and "not a single detection" - they have the workforce. Grant: is the camera positioning correct? Eldritch: stabbing was in front of camera.

Cheryl noted: Charlie Maloney coming back as neighbourhood manager (Mhairi: I didn't know)

The fact nobody had update was concerning for all.

New subgroup meeting get Soutar and Roberts [action :Cheryl] invite [action: Keith Book Larkfield 23rd April 6 PM] need to get them to public meetings too [action: Keith] get a local supervisor [action:Andy]

Comment from the floor: binmen took stuff out of bins and left behind also there selective in Westmorland Street.

Yellow bag of animal byproducts dumped by lamp posts. Marian noted this is kitchen waste-irresponsible restaurant managers ask staff to take a bag away with them period

- Traci Kirkland from Wellbeing Scotland - aware of issues of child exploitation in area and they are a "source of confidential support for any survivors of abuse or sexual exploitation". They are planning an Open Day and will invite us. [action we just publicise]
